*Pastoral Land Act 1992*  
**Delegation by Pastoral Land Board**

Under section 24(1) of the *Pastoral Land Act 1992* and with reference to section 43 of the *Interpretation Act 1978*, the Pastoral Land Board by resolution 145.13 of meeting 145 on 23 March 2022, revokes all delegations of Board powers and functions previously determined under the *Pastoral Land Act 1992* that are in force immediately before 31 March 2022; and

Under section 24(1) of the *Pastoral Land Act 1992* and with reference to section 42 of the *Interpretation Act 1978*, the Board by resolution 145.13 of meeting 145 on 23 March 2022, delegates the Board power and functions under the provisions specified in the Schedule to the Chairperson and each person from time to time holding, acting in or performing the duties of the position in the Department of Environment, Parks and Water Security specified, subject to the conditions specified with effect on and from 31 March 2022.

The issuance of these delegations does not prevent the Board from making further or specific delegations under section 24(1) from time to time.
